

## The C/N Group to collaborate with Olean General Hospital on Outpatient Surgery Center

October 31, 2011 - The C/N Group, Inc., a national healthcare services firm, has entered into a multi-year agreement to provide consulting services to Olean General Hospital in conjunction with the development of an Outpatient Surgery Center located adjacent to the Hospital's campus in Olean, New York. With construction already underway, the project consists of both a renovation of existing space as well as a significant 15,000 square feet addition. Four new operating suites will be constructed, as well as three endoscopy labs, pre-operative and post-operative recovery areas, waiting rooms, consultation areas, and support space. In addition, 23 new pre- and post-surgery bays will be installed.

It is expected that construction of the Center will be completed in April 2012.
